Project Management

Installation Services

As-Built Documentation.

As any quality program dictates, a system is not complete until it is documented. The DelcoSecurity As-Built Documentation Program ensures that As-Builts (or System Record Drawings) are completed before the system is handed over to the service teams for support. As-Built documentation includes:

- system block diagrams
- wiring diagrams
- equipment lists
- floorplans
- device schedules, and
- system training & maintenance manuals, at a minimum.
